

FACTS	WHAT DOES ST Invest, LLC (d/b/a Trade App) DO WITH YOUR PERSONAL INFORMATION?	Rev. 10/2018
<b>Why?</b>	Financial companies choose how they share your personal information. U.S. Federal law gives consumers the right to limit some but not all sharing. U.S. Federal law also requires us to tell you how we collect, share and protect your personal information. Please read this notice carefully to understand what we do.	
<b>What?</b>	The types of personal information we collect and share depend on the product or service you have with us. This information can include: <ul style="list-style-type: none"> <li>- Social Security number and government-issued ID number, or equivalent in other countries if you are a foreign individual</li> <li>- Information you provide on applications and other forms or in correspondence with us (e.g., name, physical address, email address, income, other household information)</li> <li>- Data regarding transactions made with us (e.g., account status and balances, transaction history, products/services purchased)</li> </ul>	
<b>How?</b>	All financial companies need to share customers' personal information to run their everyday business. We shall obtain your consent prior to uploading to our servers any personal information from or about you that we collect through Trade App. In the section below, we list the reasons financial companies can share their customers' personal information; the reasons St Invest, LLC chooses to share; and whether

What we do	
How does ST Invest protect my personal information?	<p>To protect your personal information from unauthorized access and use, we use security measures that comply with U.S. Federal law. These measures include computer safeguards and secured files and buildings.</p> <p>We also maintain other physical, electronic, and procedural safeguards to protect this information and we limit access to information to those employees for whom access is appropriate.</p>
How does ST Invest collect my personal information?	<p>We collect your personal information, for example, when you</p> <ul style="list-style-type: none"> <li>- Register yourself in the ST Invest's electronic portal</li> <li>- Fill out applications or other forms, or correspond with us</li> <li>- Provide account information</li> <li>- Direct us to sell securities</li> <li>- Direct us to buy securities</li> </ul> <p>We also collect your personal information from others, such as credit bureaus, affiliates, or other companies.</p>
Why can't I limit all sharing?	<p>U.S. Federal law gives you the right to limit only</p> <ul style="list-style-type: none"> <li>- sharing for affiliates' everyday business purposes--information about your creditworthiness</li> <li>- affiliates from using your information to market to you</li> <li>- sharing for non-affiliates to market to you</li> </ul> <p>State laws and individual companies may give you additional rights to limit sharing.</p>
Definitions	
Affiliates	<p>Companies related by common ownership or control. They can be financial and nonfinancial companies.</p> <ul style="list-style-type: none"> <li>- <i>StockTwits, ST Invest</i></li> </ul>
Non-affiliates	<p>Companies not related by common ownership or control. They can be financial and nonfinancial companies.</p> <ul style="list-style-type: none"> <li>- Non-affiliates we share with can include <i>ST Invest accountants, administrators, attorneys, auditors, brokers, government entities, and marketing providers.</i></li> </ul>
Joint marketing	<p>A formal agreement between non-affiliated financial companies that together market financial products or services to you.</p> <p>ST Invest's joint marketing partners can include StockTwits</p>
